#### **Moot Court Exercise and Internship**

**Objective:** The objective of having moot courts is to give the students practical tanning how the proceedings of the court takes place.

#### The Paper will have following components

- ➤ <u>Moot Court:</u> Every student may be required to do at least one moot court in a year. The moot court work will be on assigned problem.
- ➤ Observance of Trial in one case, either Civil or Criminal.
  - Students may be required to attend one trial in the course of the last year of LL.B. studies. They will maintain a record and enter the various steps observed during their attendance on different days in the court assignment.
- ➤ <u>Interviewing techniques and Pre-trial preparations and Internship diary.</u>
  - Each student will observe one interviewing session of clients at the Lawyer's Office/Legal Aid Office and record the proceedings in a diary. Each student will further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/petition.
- ➤ The fourth component of this paper will be Viva Voce examination on all the above three aspects.
- > Student will be required to undertake legal awareness programme in association with N.S.S. and other authorities as directed by the Faculty.

## LECTURE 19

He has multiple male partners in Society.
- 8. Rajeev is transferred to Kanpur in 2016. Now both partners are of 25 years age. Here Rajeev meets Suhail. They hit off immediately being a long-time friend and share goods camaraderie in spite of difference of their ranks.

- 9. Rajeev invites Suhail on dinner on 25<sup>th</sup> December, 2018 at his officer's residence. Rajeev has great culinary skills and he cooks a great meal for his dear friend. Suhail comes to know that Rajeev in the meantime has never been to home and has lost touch completely.
- 10. Rajeev asks him how is life has been these days. He says that he is going good and very joyfully explains his relationship with Saniya and how this love with this girl has motivated him to do something in life. Rajeev is amazed to see this change in his friend's behavior and calls him a lover boy. Suhail takes it as a compliment and the night ends with food and drinks.
- 11. Rajeev on 26<sup>th</sup> December sees the Stores and there he meets with Suhail and calls him lover boy again which is objected by him in a subtle way by gestures as he is his senior. Being enraged by this Rajeev becomes abusive and hurls abuses on him and makes fun of Saniya and his love for her. He does not say anything.
- 12. On 27<sup>th</sup> December in the evening around 4:45 PM when most of the staff has left premises, Rajeev enters to stores for certain supplies and purchases and picks the errands from stacks in stores and at that point of time the helpers and staff of stores has gone only Suhail is left in stores. He requests him to drop the list of items which he will see him supplied. Rajeev says that he does not like girly boy to do anything for him. Rajeev suddenly latches the store and violently assaults the Suhail on his head and he receives a concussion and fells unconscious. Rajeev satiates his carnal desire from unconscious Suhail and leaves the stores.
- 13. Regaining consciousness Suhail smells the rat and takes a treatment in the hospital. Next day he resumes the services. In the canteen Rajeev while taking breakfast cracks jokes and makes comment of lover boy and silky boy on Suhail.
- 14. On 29<sup>th</sup> December he again is humiliated by Rajeev in public view. He in the night thinks about the event again and again. This fills his heart with resentment, angst and hatred. On 30<sup>th</sup> December he borrows a Pistol from Ram Singh who is a subedar on the pretext of killing a rabid dog roaming in compound.
