

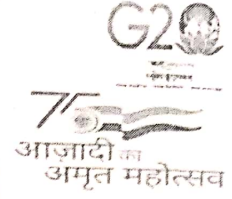

I am directed to refer to GOI's letter No.V.12025/102/2022-DE dated 27.06.2022 on the subject mentioned above, thereby forwarded a copy of letter No. RDC/Ministry/2022/6065 dated 07.06.2022 of Principal, Rama Dental College Hospital & Research Centre, requesting for shifting of Rama Dental College Hospital & Research Centre, Lakhanpur, Kanpur Uttar Pradesh to the Campus of Rama University, G.T. Road, Kanpur, Uttar Pradesh.

2. In this connection, I am directed to say that the Executive Committee of the DCI in its meeting held on 24.12.2022 considered letter No. RDC/DCI/ESTT/2022/9006 dated 22.12.2022 from the Principal, Rama Dental College Hospital & Research Centre, Kanpur (Uttar Pradesh), thereby furnishing documents/details in terms of DCI letter dated 16.12.2022 with regard to the shifting of Rama Dental College Hospital & Research Centre, Lakhanpur, Kanpur (Uttar Pradesh) to Campus of Rama University, Kanpur, Uttar Pradesh, which the same were examined by Shri Rohit Kumar Singh, DCI Advocate during the meeting and he opined that that as per documents/details received vide above letter dated 22.12.2022, the college authority fulfills all the requirement for the purpose of Shifting of Rama Dental College Hospital & Research Centre, Lakhanpur, Kanpur (Uttar Pradesh) to Campus of Rama University, Kanpur, Uttar Pradesh, and after taking into not of the above and after some discussion decided as under:-

The Govt. of India be intimated that the necessary inspection for change of place of Rama Dental College Hospital & Research Centre, Lakhanpur, Kanpur Uttar Pradesh by DCI inspectors has been carried out on 12th & 13th August 2022 to its new premises at Campus of Rama University, G.T. Road, Kanpur, Uttar Pradesh and it has been found that the college fulfills all the requirement to run BDS & MDS Course(s) as per DCI norms.
