
**NOTIFICATION**

Subject: Recognition of BDS Degree in respect of Rama Dental College hospital & Research Centre, Kanpur- Issuance of Internship Completion Certificate in respect of Ist batch of students of Rama Dental College Hospital & Research Centre, Kanpur who have taken final examinations in February, 2002-reg.

Sir,

I am directed to refer to DCI's letter No.DE-3(91)-2002/8391, dated 21.1.2003, whereby DCI had recommended to Government of India to recognize the BDS Degree awarded by Dr. Bhim Rao Ambedkar University, Agra, in respect of the BDS students of Rama Dental College - Hospital & Research Centre, Kanpur, who have admitted at this college after the Central Government Permission dated 6.2.1997 from the academic session 1996-1997 have completed their total prescribed duration of 5 years BDS Course, including the extended period of Internship up to 6.2.2002 in the Institution.

2. — In this connection, it may be mentioned that Rama Dental College - Hospital & Research Centre, Kanpur, was granted permission by the Central Government to start BDS Course on 7.2.1997 w.e.f. the academic session 1996-1997. Consequently, the college authorities were allowed to admit students after 7.2.1997. The students who took their admissions in this college, in the normal course, would have become eligible to take their 1<sup>st</sup> Final Year BDS Examination during 2001 after completing the course content and duration prescribed in the DCI's BDS Course Regulations. However, the college authorities made these students to take their 1<sup>st</sup> Final Year BDS Examination in February, 2000 after putting in less than 3 years of study, as against the prescribed 4 year duration of the BDS Course.

3. While considering the case for recognition of the BDS Degree in respect of these students of the subject dental college, it has been decided that the shortfall of duration of 4 years should be compensated by extending the Internship Period up to 6.2.2002.

4. In view of the above, you are directed to issue the Internship Completion Certificate only to the 29 students who took their 1<sup>st</sup> Final Year BDS Examination in February, 2000 w.e.f. 6.2.2002 as per the undertaking dated 18.7.2002 furnished by you.
