The academic council Vide their resolution dated 23rd July, 2018 accepted the U.G.C. New Delhi Notification on U.G.C. (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions dated 08.07.2019.

This shall be applicable for Ph.D Thesis and P.G. Dissertation.

The points are of decision are given here under:-

(3) The constitution of Institutional Academic Integrity Panel (IAIP)

- (The tenure of (b) & (c) shall be normally 2 years)

The DAIP shall consider the complaint of allegation of plagiarism or take *suomuto* notice of an act of plagiarism and initiate proceedings under the said regulation within 45 days of receipt of complaint.

The report of DAIP will be send to IAIP for consideration and its recommendation shall be final. The report shall be put-up before Academic council for relevant action, if found guilty of plagiarism.

(3) Under taking:

Every student submitting thesis or dissertation shall submit an undertaking:-

- c. That, the document has been prepared by him/her and that the document is his/her original work and free from any plagiarism.
- d. That, the document has been checked by the plagiarism detection tool as recommended by the U.G.C. New Delhi.

The said undertaking shall be countersigned by the supervisor with remark that the work done by the researcher under him/her is plagiarism free.

(4) Uploading on INFLIBNET

The soft copy of each PhD thesis approved by the R.D.C. shall be uploaded in the digital reporting under shodhganga e-repository within a month of award of degree from the university, by the incharge PhD cell.
