Minutes of Meeting

The Chairperson welcomed the members and the following points were discussed in the meeting:

Agenda 01: Review of the activities during January- March 2025

Dean R&D apprised about the announcements and result publications related to the Ph.D. entrance held in January 2025 were noted for record and follow-up by the Research & Admissions office and also uploaded on the website of the university.

Dean FJS informed that the Faculty of Juridical Sciences organised a Voter Awareness Drive in Markhara Village, Chaubepur (25 Jan 2025). The IQAC appreciated community outreach activities and recommended documentation for NAAC evidence. Faculty of Juridical Sciences organised a student march on 20 February 2025 for World Day of Social Justice.

Members were informed by Dean FASAI about the International Conference on Emerging Technologies in Agriculture and Allied Sectors for Sustainable Development (ICETASD-2025) with submission and registration schedules in Jan–Feb 2025; departments were advised to encourage faculty/student participation and to collate conference outputs for institutional repository. Dean FASAI informed that the Faculty conducted a workshop in collaboration with ADAMA India on 5 February 2025 for agriculture aspirants; members noted industry linkages and internship coordination as points for strengthening Outcome-based documentation.

Dean FPS informed that the Faculty of Pharmaceutical Sciences and Rama Institute of Pharmacy organized awareness activities and a special session on 4 February 2025 to mark World Cancer Day.

Dean DSW informed that Inter-faculty Graffiti Art competition (5-11 Feb 2025) and was conducted.

The Department of Journalism & Mass Communication ran a skill development program 17–21 Feb 2025 as informed by the HOD.

A Mission Shakti awareness / health check-up activity on 4 Feb 2025 was organized; departments were asked to ensure documentary evidence (photos, signed reports).

Rama University observed International Women's Day activities: a rejuvenating yoga session (6 March 2025) and a cultural fest on 8 March 2025 (theme "Accelerate Action"); the IQAC recommended collecting program schedules, participant lists and photographs for the NAAC evidence file.
