Memorandum of Understanding / Agreement

Between

Rama University Kanpur (U.P.)

and

A private company [**Manupra Foods Private Limited**] and centre location
1286/1, Near Lal Schol, Nai Basti, Jhanai (U.P.)

1. This Memorandum of Understanding is made on this day, the 28th October, 2021 between Faculty of Agricultural Sciences and Allied Industries, Rama University, Kanpur (U.P.) having its office at Kanpur Nagar, Uttar Pradesh which expression shall include authorized representative of first part

and

A private company [Manupra Foods Private Limited] and centre location 1286/1, Near Lal Schol, Nai Basti, Jhanai (U.P.) (herein after referred to as 'MFPL' represented by its authorized representative) of the second part. The Programme for which this MoU is signed is to be known as "RAWE and industrial Attachment Scheme" of the Government of India.

2. Whereas the MFPL is desirous of undertaking to implement the training, the two parties to this Memorandum of Understanding, with the intention of both being legally bound, accept the following terms and conditions:

3. Responsibilities of the MFPL

The MFPL shall;

- a) Appoint a Nodal Officer for signing on all documents and contact person to coordinate the RAWE and Industrial Attachment Scheme.
- b) Organize training Scheme as per the RAWE and Industrial Attachment guidelines.
- c) Agree and ascertain for itself the budget provisions for implementing the training components of the said scheme and shall fund all cost overruns if any.
- d) Not make any financial commitment on behalf of University, nor shall take loans or create any other financial liability binding University under this agreement;
- e) Have all employees relating to this said scheme on its payroll, or shall invite outside guest speakers / faculty on its own, and University shall have no legal, financial or any other responsibility towards them;
- f) Maintain proper records of documents of candidates.
- g) Provide Well-equipped training hall with capacity of 50 candidates with hostel for decent boarding and lodging facilities.
- h) Ensure safe and secure environment for trainees in boarding, lodging and during off campus visits.

i) Provide computers with necessary internet and software.

b) Responsibilities of University: The University shall:

- a. Provide broad course outline to the MFPL.
- b. Provide list of trainees allotted to each training centre.
- c. Training fees amount will be paid by concern trainees to the MFPL as per the rates fixed by scheme guidelines.

c) Force Majeure

In the event of non-fulfillment of the contract terms and conditions due to any reason of force majeure namely fires, wars, riots, strikes, natural calamities, etc., neither the MFPL nor University shall be held responsible for any loss or consequential loss.

d) Liabilities

University shall not, however, be liable for:

- a. Any payments of claims by employees of the MFPL
- b. Discharging any financial commitments made by MFPL.

e) Period of Validity

This agreement shall be valid for five years from the date of signing the agreement till 28th October, 2021 to 27th October, 2026 or such period either of the parties opts to disassociate or withdraw from the agreement. Either party can terminate the agreement with a notice of 1 month.

f) Arbitration

Any dispute arising with regard to any aspect of this Agreement shall be settled through mutual consultations and agreements by the parties to the Agreement.
