## **Types of Cooperation**

Through this Memorandum, both Parties affirm the value of collaboration and agree to promote the following

## Activities

- 1. Joint training programs for students as well as faculty in the field of mutual interest.
- 2. Exposure to Industrial Orientation for Final and Pre-final Year students through 1, 2, 3 or 5 days.
- 3. Industrial visits and guest lectures by experts.
- 4. Assistance in Placement of the deserving candidates.
- 5. Special practical training for students/teachers as per the industrial requirement.
- 6. Any other activities as mutually requested.

This Agreement places no financial obligations or supplementary funding commitments on either party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

The Dean, Faculty of Pharmaceutical Sciences, Rama University, Kanpur autonomous will serve as the primary liaison between the institutions to facilitate the development of future activities

## Terms

This agreement will become effective upon the date of signature of both Parties. It shall remain valid for a period of three (3) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both Parties. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days. The agreement may be extended by mutual consent of the two Parties after the three-year period, and it must be renewed in writing.
